Reminder: On November 3, 2015, the Town of York voted in favor of adopting the Single-Use Plastic Carry-Out Bag Ordinance that prohibits single-use carry out plastic bags provided by retailers at checkout throughout York. The ordinance took effect on March 3, 2016. Some handle-less bags for wet produce, meat and fish are still permitted. Our market is required to follow this town-wide ban. Vendors must switch over to other options and we have a reusable market bag for sale. Please check with Carol West, Market Manager, if you would like to purchase bags to have available at your booth.
