2019 Summer Application for Non-Profits

Area non-profits are encouraged to take advantage of a free booth space at our Saturday summer market once per year. Make sure your plans for the space will qualify by reading through the details/rules below.

- Non-Profits are welcome to set-up an information booth at the market when space is available. You cannot collect signatures for a petition. You are not permitted to sell anything. No soliciting or surveying by any political, religious or other special cause groups or individuals is permitted at the market. No "hawking" or calling out to customers is allowed at our market. All of your activities must take place in your booth space.
- Acceptance is based on the market manager's discretion.
- The space is 10' x 10' and located in the lower lot - you provide your own tables, tent and chairs
- Market runs from 9:00am - 1:00pm. You need to staff your booth for that entire time. Your booth must be completely set-up by 8:45am.
- There is no parking at the spot. You will unload materials, move your car down to vendor parking and return to set-up your booth space. All helpers/staffers coming to staff your booth must also park down in vendor parking.
- The market is rain or shine. If you commit to a date, you are expected to be present. Emergencies happen, but just give us notice. Empty spaces reflect negatively on the market. If you are a no-show, you won't be welcome back at a later date.
